The role, based in Witney, will promote high standards of health and safety management to maintain a positive Health & Safety culture across all the service areas.• To provide advice and guidance to managers and staff in order to assist them in meeting their health and safety obligations.• To ensure West Oxfordshire District Council, Publica and other partner Councils are compliant to relevant legislative requirements and standards, to protect employees, contractors, customers and visitors using Council premises and services.• As a Health and Safety Business Partner you will also contribute to the development, co-ordination and implementation of health and safety policies and procedures that is led by the Corporate Health and Safety Business Partner. You will also work collaboratively with the West Oxfordshire District Council Assets Team to support with all property compliance matters under direction from the Assets Manager to increase levels of health and safety property management compliance at West Oxfordshire District Council.

Main requirements of this specific role:	<p>As a Health and Safety Business Partner, your role will be to -</p> <ol style="list-style-type: none">1. Work collaboratively with the Publica Team Health & Safety Team to fulfil the objectives and delivery of the Health & Safety Team work plan.2. Support the West Oxfordshire District Council Assets Manager with all aspects of building health and safety compliance.3. Fulfil the requirement of 'Competent Person' as required in Regulation 7 of the Management of Health, Safety and Welfare Regulations 1999.4. Ensure any changes to legislation or guidance are implemented as appropriate.5. Promote and influence a strong safety culture throughout the organisation.

6. Be the point of contact to provide advice on health and safety matters and best practice to ensure compliance
7. Analyse performance data, creating regular performance reports.
8. Present performance data to local H&S Committee and feed this forward to the Corporate Health and Safety Business Partner for H&S performance and strategic higher level reporting purposes.
9. Create, implement, and review health and safety policies and procedures for effectiveness and to reflect changes in legislation.
10. Work with service area managers providing the right advice to ensure risk assessments and safe working procedures are suitable and sufficient.
11. Conduct and record internal H&S audits and offer necessary support to managers.
12. Assess first aid requirements, providing equipment, ensuring adequate cover, and arranging training.
13. Create, implement, and review evacuation procedures on a regular basis.
14. Provide fire safety training as required and arrange and review fire risk assessments.
15. Create & deliver health, safety, and wellbeing training.
16. Implement health & wellbeing initiatives in line with best practice.
17. Consult with external agencies, e.g., HSE, Fire & Rescue Services,
18. Keep up to date with industry best practice and H&S initiatives and legislation.
19. Advise on health and safety considerations during procurement process.
20. Record incidents and report to the HSE if necessary.
21. Support incident investigations and prepare reports as required.
22. Lead on project work across all areas of the council to assist in ensuring health and safety compliance.
23. Provide advice on arrangements required to ensure compliance with statutory requirements, corporate policy and good practice.

The post holder is responsible for maintaining a safe working environment and ensuring, as is reasonably practicable, that safe working practices are adopted by employees within this work environment. This will largely be achieved by undertaking on-site inspections, therefore regular attendance at all sites is required.

This compliments similar roles, at Cotswold District Council and West Oxfordshire District Council. The Corporate Health and Safety Business Partner will provide the strategic oversight and will lead policy, procedure and training activity which benefits all three partner Councils. You will be expected to support Health and Safety at the other Councils to cover absences and to work collaboratively on issues and policy that will benefit all partner councils and Publica.
